All U.S. Dancers must have a 2012 FUSTA Registration Card.

Entry fee: Pre-Premier \$15 Premier \$20

Choreography fee: Individual \$20 Group \$30

Dancing entries must be received by **February 20, 2012**
NO ENTRIES ON THE FIELD.

Registration for Pre -Premier dancers except Intermediate will begin at 9:00 A.M. and at 12:30 for all Intermediate and Premier dancers.

Dancing events will begin promptly at 9:30 A.M. starting with Highland and followed by Nationals.

The afternoon dancing will begin at 1:00 P.M. starting with Highland, Nationals and followed by Choreography.

Competitors may enter only one grade, class, or group, which includes choreography. All competitors must obtain competition numbers at the registration table, which must be worn during competition. Age groups will be determined by entries received.

Medals will be awarded to the winners of each dance listed in each section. A trophy will be awarded in each section except Primary using the SOBHD point system.

Special trophies will be awarded to the Premier Dancer of the Day, the Most Promising Beginner, and the Best Florida Dancer. The Most Promising Beginner is by Judge's decision. The Best Florida Dancer is decided on aggregate points. The Best Premier Dancer trophy will be decided by a dance off of all Premier age group winners.

Premier Dancers will receive cash prizes as follows:

Group 1 - 1st \$35, 2nd \$30, 3rd \$25, 4th \$20

Group 2- 1st \$40, 2nd \$35, 3rd \$30, 4th \$25

Group 3- 1st \$45, 2nd \$40, 3rd \$35, 4th \$30

Choreography cash prizes as follows:

Individual - 1st \$40, 2nd \$30, 3rd \$20

Group - 1st \$60, 2nd \$40, 3rd \$30

In the event of a protest being lodged, a fee of \$15 must accompany a written complaint. The fee will be returned if the protest is upheld.

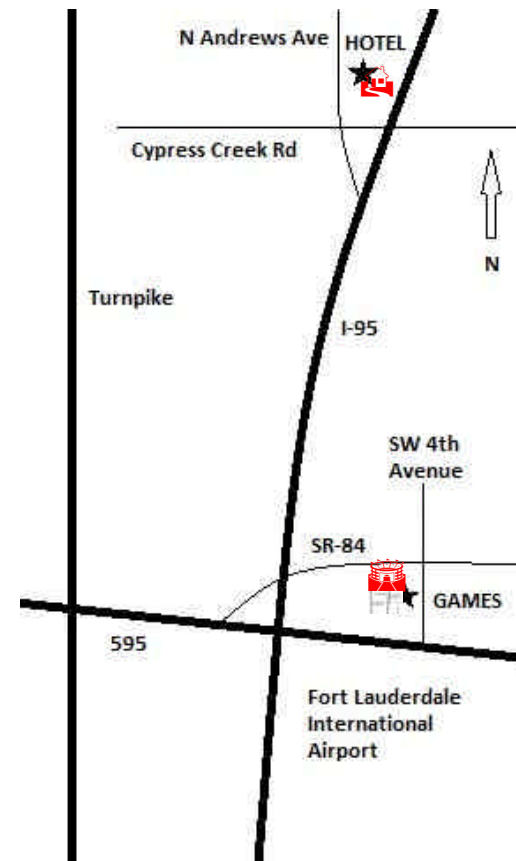
